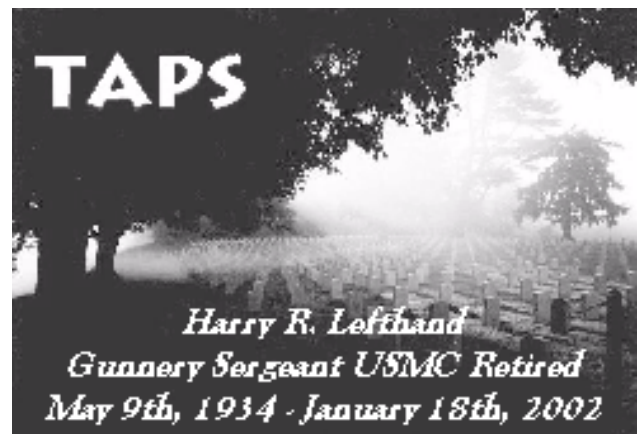

Camp Lejeune, North Carolina

The Company has been very busy over the last six months.

Currently we are in the process of moving the entire Company into our new 8 million dollar facility located at Court House Bay. The new facility will be home to 2d Recon Bn and 2d Force Recon Co.

On 9 July 2d Force Recon Co. will be conducting a change of command and we will again stand detached from 2d Recon Bn and work directly for II MEF. The following list describes the training being conducted at 2d Force Recon Co.

1<sup>st</sup> Platoon - 1stLt Buffa & GySgt Elder have recently commenced the unit-training phase. They have been selected to participate with the 2<sup>nd</sup> MEB during exercise Dynamic Mix, which is scheduled to be conducted in Spain in late May. When they return, they are scheduled to deploy for cold weather operations in Bridgeport CA.

a. 2<sup>nd</sup> Platoon - 1stLt Livotti & SSgt Salbom have just started forming the platoon and are undergoing a demanding six-month school phase. They have Marines scheduled to deploy with the 2d MEB in support of Exercise Dynamic Mix.

b. 3<sup>rd</sup> Platoon - Capt Kahn, GySgt Halpin & MSgt Weatherbe have just returned from a demanding deployment with the 26<sup>th</sup> MEUSOC in Afghanistan. They conducted several raids in support of 26<sup>th</sup> MEUSOC objectives. They have come back with a very detailed after action report concerning Force Recon employment. They are presently enjoying a well-deserved leave period. We look forward to acting on their lessons learned so future platoons can continue the war on terrorism.

## Team Somersail One

On 11 June 1967, a seven man Recon Team, "Somersail One", from 3rd Force Recon Co. left Dong Ha aboard a CH-46 helicopter for an insertion LZ at YD 041681.

The LZ was on the southern boundary of the DMZ. The area is four kilometers north of Hill 208, which was identified, during Operation Hastings in July 1966, as the Command Post for the 324B NVA Division, and 900 meters west of Hill 174, another, well known NVA position.

A flight of two CH 46A and two UH1E gun ships left Dong Ha at 1115.

As the insertion helicopter was approaching the LZ it snapped up vertically and then rolled inverted tumbling end over end and crashed. An "eye witness account" indicated it was spiraling out of control and the rear blades were separating. The helicopter crashed then burst into flames.

Within hours of the crash, rescue/recovery efforts were undertaken. However, weather, terrain but primarily heavy concentrations of NVA forces prevented success.

Members of the Recon Team aboard the CH 46 have been identified as Sgt. Jim E. Moshier, LCpl. James E. Kooi, LCpl. Michael W. Havranek, LCpl. John J. Foley, LCpl. Dennis R. Christie, Pfc. Charles D. Chomel, Pfc. James E. Widener

The CH 46 and its crew were assigned to HMM 265. The crew members are identified as Maj. John S. Oldham, Capt. Curtis R. Bolscheid, LCpl. Jose J. Gonzales, and PFC Thomas M. Hanratty.

To date, the bodies of the men lost have not been recovered and they are listed as KIA/BNR.

Queries earlier this year indicate the Joint Task Force Full Accounting (JTF FA) Office at CINCPAC, has scheduled an investigation of the crash site during the period 4 June-2 July 2002.

While JTF FA envisions few if any problems, the investigation, however, is subject to host country (Vietnam) approval, agreement, and security concerns, weather, etc.

Eddie DeLezen, a member of 3<sup>rd</sup> Force Recon Co., at the time of the incident, and Don Havranek, the brother of LCpl Michael W. Havranek, a member of the Recon team, have visited the area of the crash site. Their experiences, observations, etc. can be found on the FRA Web Site.

I was so honored to receive a standing ovation when my bio was read.

General Jones sent an official car for us again on Sunday morning to take us to the very moving ceremonies at the Tomb of the Unknown Soldier. We had box seats there and Senator Dole was seated in the box next to us. Vice President Cheney laid the wreath there and also gave a very eloquent speech.

After the ceremonies we were invited for lunch at the Army and Navy Club with the Commandant and his family. When that wonderful lunch was over the official car took us back to the hotel where we had time to recover from all the excitement before we flew home on Monday.
